It was located next to the mosque in the era of Khadidoy Ismael, a large area free, established Nubar Pasha by his own house, I knew the distance from Ramses Street to the street and Wak Baraka (Najib Rihani now) Nubar Pasha Street.

In 1969, the Mosque of Anan Sons was disassembled and stoneed.

In 1970 a decision was made to establish a new mosque and two houses were evacuated on the ground and their land was annexed to the mosque to reach 2000 square meters.
